One of the most important requirement to realise the vision of "Digital India" to transform India as a knowledge society, is to enable all citizen in the Country to be digitally literate. It is in this direction the Department has taken up National Digitally Literacy Mission (NDLM)/ 'Digital Saksharta Abhiyan' (DISHA) under which nearly 50 lakh persons all across the Country have to be made digitally literate. Please see website [www.ndlm.in](http://www.ndlm.in) for details. This programme is being implemented by CSC e-Governance Services India Ltd. (CSC-SPV) through CSCs across the country. Necessary notifications/Guidelines from the Department have already been communicated to all the States/UTs. (copies may be seen at <http://ndlm.in/guidelines-and-letters.html>)

An important component of NDLM/DISHA is to make all Anganwadi workers, ASHA workers and Authorised Ration Dealers as digitally literate. It is expected that training these people will enhance their quality of service delivery in the critical sectors supported by them. The concerned Ministries have already written to State Governments in this regard. Copies of their communications are at website <http://ndlm.in/guidelines-and-letters.html>.

We look forward to your support to mobilise the above mentioned category of beneficiaries for undergoing training at the earliest. May I mention that while you may use CSCs, the NDLM/DISHA Schemes allow training by any other organisation interested in doing this training. The guidelines for such organisations to become a training partner/centre are available at <http://www.ndlm.in/training-partners.html>. Therefore, you may also consider nominating eligible local training agencies to work with CSC-SPV in spreading the Digital Literacy Training.
